#### 2.- JUSTIFICATION OF MAIN HEADINGS

#### 1. Revenue 2006

The sources of revenue for 2006 consist of a main subsidy from the European Commission, and of grants from the Spanish Government, and the Regional Basque Authorities.

The Agency also expects to receive revenue from the sales of its publications. Furthermore, a subsidy from the EU Presidency in relation to the Closing Event of the European Week 2006 may also be received.

Main aspects of the 2006 estimated revenue consist of the established total amount € 6,080,303 for Titles 1 and 2 and for title  $3 \in 7,300,000$ . In addition, € 500,000 have been granted by the European Commission for a Phare III program, to be implemented in the period 2005-2006. Furthermore, an additional Phare program is being negotiated with the European Commission, which could result in additional funds and activities.

#### 2.- Expenditure

Budget 2005 includes updates as per amending budgets 1 and 2.

Budget 2006 includes appropriations for Commitments and Payments on operational expenses. Overall, the budget proposal remains at a level unchanged with respect to 2005, with the adjustements required on Phare III due to the anticipated timing of implementation of that program.

Budget items 1104, 1142, 3021, 3022, 3023 and chapter 31 have been deleted. Budget item 3003 has been opened.

#### Title 1 - Staff

The calculation for Title 1 is based on the assumption that the 40 posts mentioned in the proposed Establishment Plan for 2006 will be filled during the year. No additional posts in the establishment plan are requested in 2006 with respect to the approved budget for 2005. Total expenditure under Title 1 is € 4,556,173. This is the level initially approved for the 2005 budget.

#### Title 2 - Buildings, equipment and miscellaneous operating expenditure

Total expenditure under Title 2 is maintained at the level initially approved for the 2005 budget, to a total of € 1,524,130.

#### Title 3 - Operational expenditure

Operational expenditure is related to the implementation of the 2006 Work Programme and amounts to € 7,300,000. In addition, € 142,216 of earmarked Phare III expenditures are approved.
