# The European Agency for Safety and Health at Work



#### Who are we?

The Agency was set up by the European Union in order to meet the increasing needs for information in the field of safety and health at work. The Agency is located in Bilbao (Spain) with a dedicated staff of experts in safety and health, information and administration. Our goal is to improve the lives of people at work by stimulating the flow of technical, scientific and economic information between all those involved in occupational safety and health (OSH) issues. This includes workers, employers, safety representatives, experts, practitioners and national as well as European Community bodies.

# How do we operate?

The Agency's administrative board is comprised of representatives of governments, employers and workers from all EU Member States and the European Commission. We carry out much of our work through a network of nationally appointed occupational health and safety institutions known as 'focal points' in the 25 Member States, the three candidate countries and the four European Free Trade Association (EFTA) States. The focal points manage national tripartite networks. Internationally, we cooperate with organisations such as the International Labour Organisation (ILO), the World Health Organisation (WHO) and the Organisation of American States (OAS), as well as with safety and health institutions worldwide.

# What do we deliver?

The Agency has three key areas of activity.

# **Collecting information**

Europe-wide networks of designated experts and organisations have been established at national level to participate in the work of the Agency. The focal point network represents the Agency and coordinates information at national level, including a national Agency website. Groups of experts are convened to advise on individual occupational safety and health subjects. Specialist 'topic centres' assist the Agency as external consultants on specific OSH issues.

# **Communicating information**

The Internet lies at the heart of the Agency's information output. Through our network website http://osha.eu.int, users are linked to all national focal point resources and their networks. The website also provides instant and easy access to a fund of European and international OSH information, including legislation and standards, good practice, research, statistics, training and much more. From the website, users can also access the Agency's electronic newsletter, *OSHmail*, which gives updates on European and international OSH news to over 20 000 subscribers. Complementing the web services, the Agency produces a range of printed publications from factsheets and magazines on OSH topics to more detailed technical reports on specific topical issues. A programme of conferences and seminars further adds to the flow of information.

Finally, in close collaboration with the focal points, the Agency organises the annual European Week for Safety and Health at Work campaign. The campaign has two primary objectives: to raise awareness of a particular OSH problem (for example stress, the handling of dangerous substances, musculoskeletal disorders) and to promote the exchange of information and good practice, which can alleviate these problems. Over 30 countries take part and the Agency acts as the campaign coordinator, preparing the necessary campaign material and providing essential support in the promotion of the campaign throughout Europe.

# **Developing knowledge**

A third area of activity involves utilising our information networks to supply material for our own pan-European information projects on significant occupational safety and health themes. These include strategies and policies, promoting a preventive safety and health culture, safety and health information for risk sectors, anticipating risks in a changing world of work, and safety and health work in small and medium-sized enterprises.

The Agency's activities are carried out in close cooperation with all our partners to ensure that the health and safety message is effectively communicated to all parties in today's rapidly changing world of work.
