- For this Management Board meeting, the previously agreed agenda format is implemented. The
  overall purpose is to follow up on the request to allow more time for OSH content on the agenda
  and in the discussions. The way to achieve this is to give the Executive Board a stronger role in
  preparing the Management Board meeting and establish which agenda items are expected to
